What is it?

The Center for Addiction and Recovery Education at Saint Joseph's University, under a grant from the Pennsylvania Department of Health, delivers first responder, opioid response, and refresher training across the Commonwealth. Current and former first responders will train law enforcement, firefighters, and related professionals on the topics of substance use disorder and the use of Naloxone (NARCAN) as well as stigma and implicit bias when engaging persons with addiction or substance use disorder issues.

May 14 - 15 - Advanced Roadside Impaired Driving Enforcement (ARIDE) - 0830 - 1630 hrs. - No Fee

Presented by PA DUI Association

The Advanced Roadside Impaired Driving Enforcement (ARIDE) program was developed by the National Highway Traffic Safety Administration (NHTSA) with input from the International Association of Chiefs of Police (IACP) Technical Advisory Panel and the Virginia Association of Chiefs of Police. ARIDE was created to address the gap in training between the Standardized Field Sobriety Testing (SFST) and the Drug Evaluation and Classification (DEC) programs.

The class begins with a SFST review to ensure students are proficient and error free in their administration of SFSTs as they are the cornerstone of all impaired driving enforcement. Students must be able to demonstrate proficiency with the administration of SFSTs to continue with the remainder of the training. The remaining instruction introduces the seven (7) established drug categories, signs and symptoms associated with each category, methods of ingestion, paraphernalia, additional roadside tests including the Modified Romberg Balance and Lack of Convergence tests, current drug trends and an overview of the Drug Evaluation and Classification Program (DECP).

It is not designed to replace the DRE program; rather, it is intended to supplement the DECP by enabling officers to recognize impairment resulting from controlled substances and to utilize a DRE. ARIDE is a prerequisite course for Drug Recognition Expert (DRE).

May 19 - 21 - Interview and Interrogation - 0800 - 1630 hrs. - No Fee - Course #CR-557, Class #5425

Presented by Institute for LE Education

This three-day course of instruction is designed to facilitate both patrol officers and criminal investigators while dealing with deceptive subjects. It provides the student with the tools necessary to conduct suspect interviews, identify the deceptive subject and obtain confessions. We will discuss the phases of the formal interview and expose each participant to the potential utility of different questioning techniques used to obtain more detailed information in compliant subjects. An important goal of this instruction is to raise the confidence level of the officer by using a systematic approach to finding the truth so that they can confront the dishonest subject and ultimately gain the truth.

This course utilizes video from real life interviews so that the student has the opportunity to see the successful employment of the techniques that are taught. Extensive instruction and discussion of video examples that detail what deception looks and sounds like will provide the student with valuable insight into detecting deception.

We will discuss the steps to interrogation which include developing themes and tailoring a monologue, positively confronting the deceptive subject, handling any denials, redirecting their resistance to telling the truth and gaining the guilty person's trust through empathy and rapport building.

August 18 - 29 - Traffic Collision Reconstruction - 0800 - 1700 hrs. No Fee - Course #CL-305, Class #5429

Presented by Institute for LE Education

The final level of the three-core traffic collision investigation courses.

Reconstruction contains highly technical subject matter including interpreting evidence from a collision scene, reconstructing collision and using mathematical computations to determine causation factors of a collision. Officers use diagramming tools, measuring instruments and photographs, as well as elements of algebra, geometry and trigonometry in case determination.

The course includes staged collision situations and diagramming projects to provide practice in determining the speed of a vehicle in a collision, the effects of weight shift in braking, the effects of anti-skid braking systems, direction of travel, initial contact points and position of vehicle on the roadway.

Because of the highly technical subject matter, it is mandatory for each applicant to have successfully completed the On-Scene and Advanced Collision Investigation Training Courses or equivalent training from a recognized training institution.

August 20 - Standard Field Sobriety Testing Refresher - 0830 - 1230 hrs. - No Fee

Presented by PA DUI Association

The curriculum for this course is through the National Highway Traffic Safety Administration and the IACP. This course refreshes officers in the three (3) phases of DUI detection, proper administration and interpretation of the Standardized Field Sobriety Tests, covers recent and pertinent case law and provides updates and any changes to the current curriculum for the Basic Standardized Field Sobriety Tests.

This 4-hour refresher course is recommended by NHTSA to be taken every 2 years for officers who have completed the SFST Basic Practitioner Class and required every 2 years by PennDOT if the officer is a member of an Impaired Driving Task Force.

August 20 - Sobriety Checkpoint Refresher - 1300 - 1700 hrs. - No Fee

This 4-hour course is designed to fulfill NHTSA / IACP and PennDOT requirements that officers having already attended the 8-hour Sobriety Checkpoint Training and working sobriety checkpoints receive periodic refresher training. NHTSA / IACP and PennDOT require checkpoint refresher training every four (4) years for officers who work checkpoints. Officers successfully completing the curriculum receive a certificate and are considered trained in compliance with NHTSA / IACP and PennDOT guidelines.
